

Status of the Hungarian Protocol Updated as of 19/6/2023

During the summer session of the Knesset the coalition changed strategies – from a focus on the legislation of the "judicial reform" to parallel moves on various fronts. From a legislative blitz to "the salami slicing tactics". The method changed, but the objective remained the same – a regime coup, from democratic to authoritarian regime, following the "Hungarian protocol".

The Hungarian protocol includes five stages: cancelation of the independence of the justice system; disruption of proper administration and election procedures; taking control over public communications and free media; narrowing the rights of individuals, minorities, women, the LGBTQ community, and religious coercion; and narrowing the freedom of speech – in Academia, arts and culture.

As of June 19, 2023, the coalition presented 193 bills that fully execute the Hungarian protocol.

Below are selected examples of the bills, by category:

Cancelation of the independence of the justice system – 73 bills
